TOWN OF MILLERSBURG, INDIANA

AN ORDINANCE APPROVING A CONTRACT FOR PURCHASE
OF ELECTRICAL SERVICE FOR THE PARK AND RECREATION DEPARTMENT

Section 1. BE IT ORDAINED by the Town Board of the Town of Millersburg, County of Elkhart, in the State of Indiana, that said Town does make and enter into a contract with Northern Indiana Public Service Company, an Indiana corporation, for the purchase of electrical service for the Park and Recreation Department at Larimer Dr. Extended, in said Town, and that the contract and the form now here presented to the Town Board is approved, and the Town Board President is authorized to execute the same in the name of and in behalf of said Town, and the Clerk Treasurer is authorized to attest the same with his signature and affix the corporate seal of said Town and when the same is executed by the Town Board President and attested by the Clerk Treasurer and duly executed by the Northern Indiana Public Service Company, it shall be in full force and effect.

Section 2. The Clerk Treasurer to identify said contract is hereby directed to spread a copy of said contract on the records following this ordinance.

Section 3. This ordinance shall be in full force and effect from and after its passage.
