**AN AMENDMENT TO REOLUTION 05-704d THE "ELKHART COUNTY 2006
COMPREHENSIVE LAND USE PLAN" BY ADDING THE TOWN OF MILLERSBURG'S
COMPREHENSIVE PLAN DATED APRIL 2021**

WHEREAS, under applicable Indiana law, a Comprehensive Plan shall be approved by resolution of the Board of Commissioners of the County of Elkhart, Indiana and in cooperation with the Town Council of Millersburg in order to promote of public health, safety, morals, convenience, order and the general welfare and for the sake of the efficiency and economy in the process of development; and

WHEREAS, on November 21, 2005, the Board of County Commissioners adopted the "Elkhart County 2006 Comprehensive Land Use Plan".

WHEREAS, the Town of Millersburg has caused to be prepared a new Comprehensive Plan dated April 2021 and has requested to have it included in the Elkhart County 2006 Comprehensive Land Use Plan for the Town of Millersburg area.

WHEREAS, on August 12, 2021, the request to amend the Elkhart County 2006 Comprehensive Land Use Plan for the Town of Millersburg area by the addition of The Town of Millersburg's Comprehensive Plan dated April 2021 was heard by the Elkhart County Advisory Plan Commission and which did take public input at the meeting; and

WHEREAS, The Town of Millersburg's Comprehensive Plan dated April 2021 has been certified to the Board of County Commissioners of Elkhart County, Indiana, with a favorable recommendation from the Elkhart County Advisory Plan Commission.


**THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY OCMMISSIONERS

Section 1: The Elkhart County 2006 Comprehensive Land Use Plan is amended to include the Town of Millersburg's Comprehensive Plan dated April 2021 as certified to


