## **RESOLUTION NO. 2021-12**

## RESOLUTION ADOPTING MILLERSBURG COMPREHENSIVE PLAN

WHEREAS Indiana Code 36-1-3 permits any unit in the State of Indiana to exercise any power or to perform any function necessary to the public interest in the context of its governmental or internal affairs, which is not prohibited by the Constitution of the United States or of the State of Indiana, or denied or pre-empted by any other law, or is not expressively granted by any other law to another governmental entity;

WHEREAS the Town Council of the Town of Millersburg, Indiana is the Town legislative body and is by law authorized to adopt ordinances and resolutions for the performances of functions for the Town of Millersburg, Indiana;

WHEREAS the Town of Millersburg, Indiana has reviewed and considered the 2006 Elkhart County Comprehensive Plan as applicable to the Town of Millersburg and has developed a proposed amendment to the 2006 Elkhart County Comprehensive Plan as applicable for the Town of Millersburg, Indiana known as the Town of Millersburg, Indiana 2021 Comprehensive Plan:

WHEREAS the Town of Millersburg, Indiana submitted an application to amend the 2006 Elkhart County Comprehensive Plan, as applicable in the Town of Millersburg, Indiana known as the Town of Millersburg, Indiana 2021 Comprehensive Plan;

WHERREAS after roper legal notice and a public hearing was held provided by applicable law, the Elkhart County Plan Commission did find that all elements of the law had been met and did on the 12<sup>th</sup> day of August, 2021 recommend to amend the 2006 Elkhart County Comprehensive Plan, as applicable for the Town of Millersburg, Indiana with the Town of Millersburg, Indiana 2021 Comprehensive Plan;

WHEREAS the Elkhart County Plan commission has filed and certified its recommendation with the Town Council of the Town of Millersburg, Indiana and the Board of Commissioners of the County of Elkhart, Indiana;

In addition, the Town of Millersburg, Indiana 2021 Comprehensive Plan shall be placed on file in the Office of the Elkhart County Recorder.
